## WHAT DOES HENLEY & COMPANY & HENLEY & COMPANY WEALTH MGMT DO WITH YOUR PERSONAL INFORMATION?

<b>Why?</b>	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
<b>What?</b>	The types of personal information we collect and share depend on the product or service you have with us. The information can include: <ul style="list-style-type: none"> <li>- Social Security Number and Employment Information</li> <li>- Account Balances and Account Activity</li> <li>- Credit Information and Mailing Address</li> </ul> When you are no longer our customer, we continue to share your information as described in this notice
<b>How?</b>	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Henley & Company chooses to share; and whether you can limit this sharing.

<b>What we do</b>	
How does Henley & Company collect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings. We restrict access to nonpublic personal information about you to those employees and service providers who need to know that information to provide products and services to you.
How does Henley & Company collect my personal information?	We collect your personal information, for example, when you <ul style="list-style-type: none"> <li>- Open an account or change your information</li> <li>- Present Government ID or perform transactions</li> <li>- seek advice on your investments</li> </ul> We also collect your personal information from others, such as credit bureaus, affiliates, or other companies
Why can't I limit all sharing?	Federal law gives you the right to limit only <ul style="list-style-type: none"> <li>- sharing for affiliates' everyday business purposes – information about your creditworthiness</li> <li>- affiliates from using your information to market to you</li> <li>- sharing for nonaffiliates to market to you</li> </ul> State laws and individual companies may give you additional rights to limit sharing.
<b>Definitions</b>	
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. <ul style="list-style-type: none"> <li>- Our affiliates include Henley &amp; Company Wealth Management LLC.</li> </ul>
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies. <ul style="list-style-type: none"> <li>- Henley does not share with nonaffiliates so they can market to you.</li> </ul>
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. <ul style="list-style-type: none"> <li>- Henley does not jointly market.</li> </ul>

### **Other important information**

**For California:** In accordance with California law, Henley & Company will not share information we collect about California residents with companies outside of Henley & Company, except as permitted by law, such as with the consent of the customer or to service the customer's accounts. We will limit sharing among our companies to the extent required by California law.
